The original Trust Deed dt.6-4-1984 registered as Document No.100/1984 shall stand amended as under.

1. In Para No.3 under the objects of the Trust the following clause shall be added and read as part and parcel of the original Trust Deed.

Column (nn) - To establish, operate and manage educational and research institutions (including teaching hospitals) in medical, dental, nursing, paramedical, engineering and technology, humanities and allied fields of activity any where in India

2. In Para No.6 regarding the holding of office by the Trustees the following lines shall be added at the end of Para No.6 after the word "other Trustees",

"Filling up any vacancy or appointment of fresh trustees to the sanctioned strength shall be carried out by the remaining Trustees at the pleasure of His Holiness Sri Sankaracharya Swamigal of Kanchi Kamakoti Peetam".

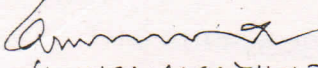
3. In Para No.11 regarding the Powers of the Trustees the following clause (y) shall be added and read as part and parcel of the original Trust Deed.

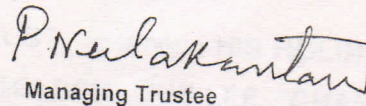
(y) - The Trustees shall have the power, by means of a resolution, to authorize any one or group of trustees to perform all acts and deeds for and on behalf of the Trust.

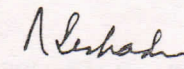
The above amendments shall form part of the main trust Deed and shall come into effect and have the force from this day.

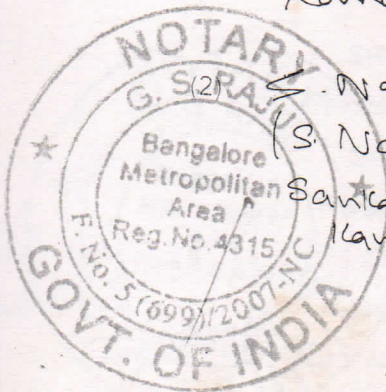
